²Monthly interest will be charged on promotional purchases from the purchase date at a reduced 5.99% APR, and fixed monthly payments are required equal to 2.00% of initial promotional purchase amount until promotion is paid in full. Regular account terms apply to non-promotional purchases.

³No monthly interest will be charged on promotional purchase and fixed monthly payments are required equal to 4.00% of initial promotional purchase amount until promotion is paid in full. Regular account terms apply to non-promotional purchases.

⁴No monthly interest will be charged on the promotional purchase if you pay the promotional purchase amount in full within 18 Months. If you do not, monthly interest will be charged on the promotional purchase from the purchase date. Fixed monthly payments are required equal to 2.50% of the highest balance applicable to this promotional purchase until paid in full.
